

QuickDocX Affiliate Program - Terms & Conditions

These Terms & Conditions (“Agreement”) govern participation in the QuickDocX Affiliate Program (“Program”) operated by QuickDocX (“Company”, “we”, “our”, or “us”). By joining the Program, you (“Affiliate”, “you”, “your”) agree to abide by this Agreement in full.

1. Eligibility

- You must be at least 18 years of age to participate.
- Your website(s), social media profiles, or marketing methods must comply with applicable laws and must not contain content that is unlawful, defamatory, obscene, or otherwise inappropriate.
- We reserve the right to reject any application at our sole discretion.

2. Enrollment

- Apply through our affiliate signup process.
- Approval or rejection will be communicated via email.
- You may not participate if your application is rejected unless you reapply and are approved.

3. Affiliate Responsibilities

- Promote QuickDocX using approved banners, links, or creatives provided in your affiliate dashboard.
- Do not engage in spam, unsolicited emails, misleading advertising, or prohibited paid search bidding (including bidding on our brand name or variations).
- Maintain your account information up to date, including payment and contact details.

4. Commissions

- Affiliates earn a 30% commission on qualifying sales referred through their unique tracking link or assigned coupon code.
- Special affiliate coupons provided by QuickDocX may offer customers an exclusive discount while ensuring the affiliate receives credit for the sale.
- Coupon usage will be logged and tracked in our system to provide a verifiable audit trail of commissions earned.
- Commission is based on the net sale amount (excluding taxes, refunds, and chargebacks).
- A 365-day cookie applies for tracking link referrals; coupon code sales are credited at the time of purchase.

5. Payment Terms

- Payments are issued monthly via [PayPal / Bank Transfer] when the minimum unpaid balance of \$100 is reached.
- Balances under \$100 will roll over to the next month until the threshold is met.
- Any refunded or disputed transactions will result in commission reversal.

- Affiliates are responsible for any applicable taxes on earnings.

6. Prohibited Activities

Affiliates must not:

- Use their own affiliate link or coupon code to purchase QuickDocX products (“self-referrals”).
- Misrepresent QuickDocX or make false claims about our products.
- Use illegal or unethical marketing practices.
- Register domain names that include “QuickDocX” or our trademarks.
- Run paid ads that compete with our own campaigns without permission.
- Post coupon codes to third-party discount or deal sites unless expressly approved.

7. Intellectual Property

- You are granted a limited, non-exclusive, revocable license to use QuickDocX trademarks, banners, and materials solely for participation in the Program.
- All rights remain with QuickDocX.

8. Termination

- Either party may terminate this Agreement at any time, with or without cause, by written notice.
- Upon termination, you must remove all QuickDocX branding and affiliate links from your materials.
- Commissions earned before termination will be paid according to the payment schedule, provided the minimum payout threshold is met.

9. Limitation of Liability

- QuickDocX will not be liable for indirect, incidental, or consequential damages arising from this Agreement.
- We do not guarantee uninterrupted tracking or that the Program will result in any specific level of income.

10. Modification of Terms

- We may update or modify these Terms at any time. Continued participation after changes constitutes acceptance of the updated Terms.

11. Governing Law

- This Agreement will be governed by and construed under the laws of [Your Country/State], without regard to conflict of laws principles.
